





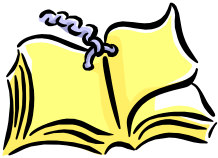

**Judging from all the positive feedback we receive, I gather that we're doing okay so far,** and I appreciate all those who communicate with us directly with their comments whether positive or negative.

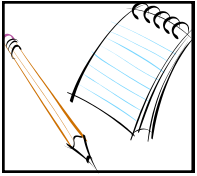

# HAPA Board of Directors February Meeting MINUTES

A regular meeting of the Hicks Airfield Pilots Association Board of Directors was held on 13 November 2008 in Hangar 111. A quorum being present, the meeting was called to order at 6:31 pm.

Board members present were Mr. Jim Usher (Treasurer), Mr. Don Browning (Secretary), Mr. John Unangst, Mr. Coy Surlles, Mr. Ted Kelso, Mr. and Gene De Bullet (President), and Mrs. Melana Sinclair (Assistant Secretary). Eight members of the Association were also present as observers.

Mr. Usher (Treasurer) submitted the September 2008 Financial Report, which was approved as written.

Don Browning submitted the Minutes from the October BoD meeting, which were approved as written.

There was discussion concerning the South Gate Project, and access to the Airfield via the property owned by Burlington Northern. It appears that the last missing Deed was located, and Burlington has offered to sell HAPA the property in question. The BOD recognizes that in order to purchase the property a vote from the membership is required; however there will not be sufficient time to arrange for that vote to occur at the annual meeting.

Don Browning announced that in his role as AOPA Airport Support Network volunteer he had installed AOPA Airport Watch signs at all gates. He also informed those present that he had additional AOPA Airport Watch decals, if anyone desired them. Don then provided the opportunity for all those present to view an Airport Watch video.

There were no additional reports made by the various committees.

The 2009 budget was approved as written, and will be published in the January 2009 Flappings. The assessments will remain the same as in 2008, and new payment books were to be mailed.

There being no additional business to discuss, the meeting was adjourned at 6:40 pm.
