} COVENANTS, CONDITIONS AND RESTRICTIONS
COUNTY OF TARRANT }

WHEREAS, HICKS AIRFIELD, INC., a Texas corporation, as Declarant, placed of record that certain Declaration of Covenants, Conditions and Restrictions of HICKS AIRFIELD, executed December 3, 1985, recorded in Volume 8396, Page 1458, Deed Records, Tarrant County, Texas; and

WHEREAS, HICKS AIRFIELD, INC., previously amended the Declaration of Covenants, Conditions and Restrictions by Amendment to Declaration of Covenants, Conditions and Restrictions executed August 31, 1987, and recorded in Volume 9066, Page 259, Deed Records, Tarrant County, Texas; and

WHEREAS, HICKS AIRFIELD, INC., is the owner of more than sixty (60%) percent of the lots.

NOW THEREFORE, the Declaration of covenants, conditions and restrictions are amended as follows:

1. HICKS AIRFIELD, INC., hereby revokes Article III, paragraph A, subparagraph I, and declares that at no time shall the Hicks Airfield Pilots Association or any other entity be authorized to charge or collect a license fee for the purpose of landing, taking off or taxiing aircraft. Any references or provisions in the Declaration of Covenants, Conditions and Restrictions for the imposition, collection or use of a license fee for the purpose of landing, taking off, or taxiing aircraft are hereby revoked and hereafter null and void.

All other portions of said Declaration shall remain unchanged and in full force and effect.




