**CORRECTION TO FIFTH AMENDMENT OF DECLARATION OF
COVENANTS, CONDITIONS AND RESTRICTIONS FOR HICKS AIRFIELD,
TARRANT COUNTY, TEXAS**

This Correction to Fifth Amendment of Declaration of Covenants, Conditions and Restrictions for Hicks Airfield, Tarrant County, Texas is made this 9th day of August, 1999, Hicks Airfield Pilots's Association, a Texas non-profit corporation (the "Association").

WITNESSETH:

WHEREAS, the Association executed that certain Fifth Amendment of Declaration of Covenants, Conditions and Restrictions for Hicks Airfield, Tarrant County, Texas (the "Fifth Amendment"), dated December 17, 1998, filed in the Deed Records of Tarrant County, Texas, on August 3, 1999, Clerk's File No. D199194918, where in the Association amended that certain Declaration of Covenants, Conditions and Restrictions for Hicks Airfield recorded in Volume 8396, page 1458, Deed Records, Tarrant County, Texas, as amended by that certain Amendment to Declaration of Covenants, Conditions and Restrictions (the "First Amendment") recorded in Volume 9066, Page 259, Deed Records of Tarrant County, Texas, and as amended by that certain Second Amendment to Declaration of Covenants, Conditions and Restrictions (the "Second Amendment") recorded in Volume 10505, Page 1485, Deed Records of Tarrant County, Texas, and as amended by the certain Third Amendment to Declaration of Covenants, Conditions and Restrictions (the "Third Amendment") recorded in Volume 12795, Page 145, Deed Records of Tarrant County, Texas, and as amended by the certain Fourth Amendment to Declaration of Covenants, Conditions and Restrictions (the "Fourth Amendment") recorded in Volume 13275, Page 8, Deed Records of Tarrant County, Texas (the Declaration of Covenants, Conditions and Restrictions, as so amended by the First, Second, Third, Fourth and Fifth Amendments, is herein referred to collectively as the "Declaration").

WHEREAS, Section 9, on page 15 of the Fifth Amendment to the Declarations incorrectly included additional lots of the Silverado Tract, described in Exhibit "B" attached hereto, to be a part of the restrictions reserved to the Owner of Lots 6-3 & 6-4 of the Phase I Property, described in Exhibit "A" attached hereto, over and to the easement described in the Fourth Amendment.

WHEREAS, the Association, with the approval and consent of Silverado Development Corporation and Hicks Airfield, Inc., desire to correct the inadvertent error by deleting Section 9 of the Fifth Amendment and replacing same with the Section 9 set forth herein.

NOW, THEREFORE, the Association hereby declares that the Section 9 on page 15 of the Fifth Amendment of the Declaration is hereby deleted in its entirety and replaced with the following:

Section 9. The Fourth Amendment is hereby amended to read and be as follows:

"NOW THEREFORE, the Declaration is amended as follows:

Article III is amended by adding the following sentence to the end of Subsection (A)(3):

Notwithstanding the foregoing, the easement described in this Subsection (A) that is reserved or shall exist over that portion of Lot 6-3, 6-4, 5-2, or 5-1, Block 1, Hicks Airfield, an Addition to Tarrant County, Texas, as described in the Revised Plat recorded in Volume 388-205, page 50, Plat Records of Tarrant County, Texas, and that portion of Lot 11-R & 12-R, Block 2, Hicks Airfield Section Two an Addition to Tarrant County, Texas, as described in the Revised Plat Recorded in Cabinet A, Slide 3515, Plat Records of Tarrant County, Texas, shall be limited to airplanes and to airplanes and other vehicular traffic availing themselves of the services offered by the businesses operated by the Owner of Lot 6-3 & 6-4 of the Property described on Exhibit "A" attached hereto and for no other vehicular traffic."

The Declaration, except as expressly corrected hereby, remains in full force and effect and is hereby ratified and confirmed.
